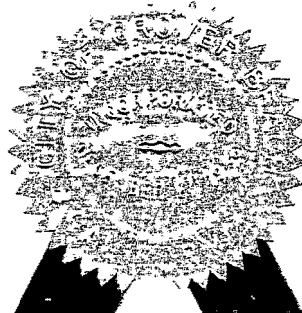

WHEREAS, during his service on the Planning Commission, he served honorably as Vice Chair in 2009 and 2010 and Chair in 2010 and 2011; and

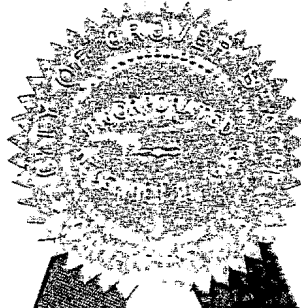
