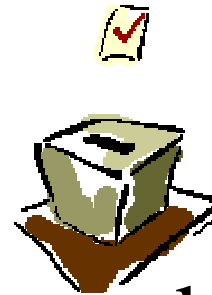

# *Grover Beach Political Sign Regulations*

---

Did you know . . .

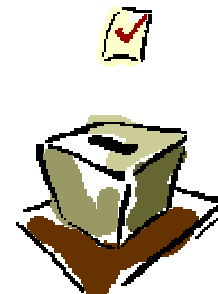


- That political signs may not be posted more than sixty (60) days prior to the date of the election to which they pertain and must be removed within seven (7) days after such election. *(GBMC Section 9401(d)(GG)*

# *Grover Beach Political Sign Regulations*

---

- Therefore for the November 4, 2008 election, political signs may be posted no sooner than September 5<sup>th</sup> and must be removed by November 11<sup>th</sup>.

## *Political Sign Regulations*

---

- We ask your cooperation:

Please refrain from posting no more than one sign per candidate or political issue on your property.

# *Grover Beach Political Sign Regulations*

---

- ❑ Political signs may not exceed a total of three (3) square feet for each property within residential zones.
- ❑ Political signs may not exceed a total of ten (10) square feet for each property within nonresidential zones.

*GBMC Section 9402(b)(A)(6)*



# *Grover Beach Political Sign Regulations*

---

## □ *New regulation this year..*

Size limitations regarding signs are applicable:

- Per Candidate,
- Per Ballot Proposition, and
- Per Issue

# *Grover Beach*

## *Political Sign Regulations*

---

- ❑ Political signs may not be attached to or placed adjacent to any utility pole, traffic sign post, or any other official traffic control device. *GBMC Section 9402(c)(2) in accordance with Section 21464 of the CVC.*
- ❑ Political signs located on or extending over public property are subject to removal by Code Enforcement.

## *Political Sign Regulations*

---

### **The City's Right-of-Way**

	<b>Sidewalk Locations</b>	<b>In the Absence of a Sidewalk</b>
<b>Allowed Locations</b>	<b>Placed “behind” the sidewalk, which means the side of the sidewalk that is located furthest away from the street.</b>	<b>Placed at least 6’ from the face of the curb or berm.</b>
<b><u>Not</u> Allowed</b>	<b>Placed in the landscaped strip <u>between</u> the street and the sidewalk.</b>	<b>Placed <u>less</u> than 6’ from the face of the curb or berm.</b>

## *Political Sign Regulations*

---

- ❑ Theft or vandalism of campaign signs is against the law! Anyone caught stealing or damaging campaign signs could be fined \$1,000 or spend 6 months in jail.
- ❑ Anyone with information on this type of illegal activity is encouraged to contact the Grover Beach Police Department at (805) 473-4511.
- ❑ We encourage all citizens to respect and support the election process.
