🐞 NOTICE OF VACANCIES 🐞 **CITIZEN OVERSIGHT COMMITTEE**

NOTICE IS HEREBY GIVEN that the City of Grover Beach is seeking volunteers for positions on City Commissions and Committees. The City recruits applicants by publishing Notices of Vacancies in the local newspapers, posting notices in the City's three (3) public posting locations, and posting a notice on the City website and Government Cable Access Channel 20.

NOTICE IS FURTHER GIVEN that the City of Grover Beach is currently seeking citizens interested in serving on the Citizen Oversight Committee.

Four (4) seats on the Citizen Oversight Committee are now open. Three (3) seats are unfilled vacancies on the committee, with terms scheduled to expire on January 15, 2016. One (1) seat is for an unscheduled vacancy scheduled to expire on January 15, 2014.

The Citizen Oversight Committee is a body of five (5) Grover Beach residents who are to meet regarding the one-half percent sales tax increase approved by a majority of the voters at the November 2006 General Municipal Election (Measure X-06). The Citizen Oversight Committee is tasked with reviewing an annual public report regarding expenditures from the one-half percent Transactions and Use Tax and budgeted expenditures for the upcoming fiscal year. The Citizen Oversight Committee then provides a report regarding expenditures of revenues generated from the Transaction and Use Tax to the City Council no later than six months following the close of the fiscal year.

Citizen Oversight Committee meetings are scheduled as needed, but not less than once annually. Meetings are open to the public and subject to the Brown Act. Applications are available at the City Clerk's Office, Grover Beach City Hall, 154 South Eighth Street, Grover Beach and on the City website at www.grover.org > Government > General Board Information. Applicants are typically interviewed by a screening committee before official appointments are made by the City Council.
