## **NOMINATION PERIOD TO BEGIN FOR CITY COUNCIL CANDIDATES**

GROVER BEACH, CA — Grover Beach voters will have an opportunity this year to vote for candidates to fill **two (2) seats** for the office of City Council Member and **one (1) seat** for the office of directly-elected Mayor. The General Municipal Election will be held in conjunction with the Statewide Consolidated General Election on Tuesday, November 4, 2014. To be eligible for a seat on the City Council, a candidate must live in and be a registered voter of the City of Grover Beach.

The nomination period for Grover Beach City Council candidates begins **Monday, July 14, 2014**.

- ❖ **For the Office of Council Member:** The nomination period runs from Monday, July 14 - Friday, August 8, 2014. One of the officeholders is precluded from running for re-election due to term limits (no more than two consecutive terms). Therefore, the nomination period for the office of Council Member is extended for five days (for *non-incumbents only*) until Wednesday, August 13, 2014 at 5:00 p.m. Terms of office for Council Members are four years.
- ❖ **For the Office of Mayor:** The nomination period runs from Monday, July 14 - Friday, August 8, 2014. If nomination papers for the *incumbent* are not filed by the close of the nomination period, the nomination period will be extended for five days (for *non-incumbents only*) until Wednesday, August 13, 2014 at 5:00 p.m. The term for the office of Mayor is two years.

The filing fee for nomination papers is \$25, plus an optional deposit towards the printing of a Candidate's Statement of Qualifications in the sample ballot. Candidates must also file a Statement of Economic Interests (Form 700) and certain Campaign Statements as required by state law.

City Council meetings are held on the first and third Mondays of each month, with special meetings or workshops scheduled as needed. Elected officials receive a stipend of \$300 per month. The City Council also serves as the Board of Directors for the City's Financing Authority and Successor Agency to the Dissolved Grover Beach Improvement Agency (redevelopment agency) for which there is no additional monetary compensation. The Mayor and Council Members also attend various committee and board meetings throughout the County to which they are assigned, as well as represent the City at numerous functions. Additional stipends and reporting requirements apply for serving on certain outside agency boards.
