Dear Council Members—

I submit the attached excel graph depicting vote counts over time in the race for the 2-year council seat.

I plotted the line graph using numbers reported and available for download on the Clerk's website.

I am still investigating what these numbers might mean, but for now simply point out the sharp increase in my vote total according to the 11/6 update, bringing me to within ten votes of Robert.

Subsequently, my vote total held to a remarkably constant amount below Robert's.

It is my supposition that the sharp increase in my vote total on 11/6 was due to late doorknocking throughout most of the City. However, this is a trend that should have continued beyond 11/6 and likely would have further accelerated in degree, because I continued doorknocking up until election day. (I don't believe my opponents engaged in such doorknocking.)

Of course it is premature to say what all this means, and we may never know for sure, but I note that our county uses Dominion machines which are susceptible to tampering. I am investigating whether Dominion IT contractors (onsite or elsewhere) adjudicated batches of votes, and whether that might have been done in favor of or in opposition to various lists of candidates (eg, SLO Trib or GOP endorsements).
