SUBJECT: Appointments to the Citizens Oversight Committee for City Revenue

Measures

RECOMMENDATION

Adopt the Resolution appointing Donna De La Rosa, Karen Kass, and Jonathon Reynolds to the three vacant seats on the Citizens Oversight Committee for City Revenue Measures; and introduce Committee Members De La Rosa, Kass, and Reynolds to the City Council and members of the audience.

BACKGROUND

The City currently has three vacancies on the Citizen Oversight Committee for City Revenue Measures and has received three applications for these vacancies. Given the interest in the Committee having a full composition, Mayor Lee is recommending that the Council make a direct appointment for the three applicants currently in consideration: Donna De La Rosa, Karen Kass, and Jonathon Reynolds. These newly appointed Commissioners will be sworn in at the next Committee meeting which will be scheduled in July.

FISCAL IMPACT

There is no anticipated fiscal impact from the recommended action.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF GROVER BEACH, CALIFORNIA, APPOINTING DONNA DE LA ROSA, KAREN KASS AND JONATHON REYNOLDS TO SERVE ON THE CITIZENS OVERSIGHT COMMITTEE FOR CITY REVENUE MEASURES

WHEREAS, a Citizen Oversight Committee was formed with the adoption of Ordinance No. 06-12 for Measure X-06 which established a 0.5% Transaction and Use Tax as a general fund revenue composed of five voters charged with an annual review on expenditure of revenues generated from Measure X-06 and a report regarding their finds to the City Council; and

WHEREAS, on July 21, 2014 Ordinance 14-05 formed a Citizen Oversight Committee for Measure K-14 Street Bonds consisting of three voters of the City of Grover Beach charged with an annual review of all Bond proceeds, expenditures and an annual report to the City Council regarding their findings of those expenditures; and

WHEREAS, on November 3, 2020 Measure F-20 was approved by Grover Beach Voters approving a 1% Transaction and Use Tax; and

WHEREAS, on December 7, 2020 City Council adopted Resolution No. 20-47 combining the Citizen Oversight Committee for Measure X-06 and the Citizen Oversight Committee for Measure K-14 to create the Citizen Oversight Committee for City Revenue Measures to include the new Measure F-20 and the 1% Transaction and Use Tax; and

WHEREAS, Resolution No. 20-47 expanded the Committee to five positions.

WHEREAS, the Council considered the applications presented to them by staff for the three vacancies.

NOW, THEREFORE, BE IT RESOLVED that the City Council of the City of Grover Beach hereby appoints Donna De La Rosa, Karen Kass and Jonathon Reynolds to serve on the Parks, Recreation, and Beautification Commission each for a four-year term of office, scheduled to expire on May 31, 2025.
