Amenities

- Chairs - \$1.00 /ea (There are 125 chairs in each facility)
- Tables - \$2.00/ea (There are twelve 8' tables and six 6' tables in the Community Center and eleven 8' tables and five 6' tables in the Ramona Garden Park Center)
- Use Stereo System- \$5 , Projection Screen - \$10 each
- 100 Cup Coffee Pot, Lectern - \$10 each

Other charges that may apply if alcohol is served, or if live music/DJ will be part of the event.

If alcohol will be served or sold:

- * Copy of contract with licensed & bonded Security Company (One security guard for every 50 guests)
- * Copy of insurance certificate listing the "City of Grover Beach" as "additional insured", with a minimum of \$1,000,000.00 general liability coverage.
- * Cleaning fee: Ramona Garden Park—\$250
Grover Beach Community Center - \$250

If DJ, but no alcohol:

- * Copy of contract with licensed & bonded Security Company (One security guard for every 50 guests)

Notes for facility renters:

No use of candles or confetti allowed in city facilities.

USER GROUP DEFINITIONS:

City Sponsored: Activities sponsored by the City of Grover Beach Parks and Recreation Department, or used by a Federal, State, or Local Government Agency.

Grover Beach Non-Profit: Non-profit agencies or other groups that by nature serve the needs of the City and Community and are based in Grover Beach. The Agency's mailing address must be in Grover Beach. Proof of 501.c.3 tax exempt certificate required.

Other Non-Profit: Non-profit agencies or other groups that by nature serve the needs of the Community whose address is not located in Grover Beach. Proof of 501.c.3 tax exempt certificate required. Must be approved by the Parks and Recreation Program Director.

Private Resident & Non-Resident: All groups or individuals that do not qualify as City Sponsored, Grover Beach Non-Profit or Other Non-Profit.

Impact Definitions:

- * **Low Impact:** Event is defined as any meeting/party/event which **DOES NOT** include any of the following: Food, drink, alcohol served or sold, band or DJ, bounce house and/or pony rides.
- ** **High Impact:** Event is defined as any meeting/party/event which **DOES** include any of the following: Food, drink, alcohol served or sold, band or DJ, bounce house and/or pony rides.

Facility Use Deposit: \$83 (refundable 7 - 10 business days after return of the key, provided area is clean and ready for next rental. Includes cleaning the barbecue grill and surrounding surfaces. Ashes are **not** required to be removed. Barbecue key must be returned to Parks & Recreation.)

The use of Bounce Houses are allowed in City Parks; however, the company providing the bounce house services is required to possess a Business Tax Certificate (BTC) to conduct business in the City of Grover Beach, and must provide a certificate of liability insurance listing the "City of Grover Beach" as "additional insured". As of 7/1/22, the following companies meet these requirements:
